Thank you for your request received on 3 October 2019, for the following information:

I request correspondence between the council and the electoral commission about the 2016 voting shambles, including correspondence in relation to any claims of maladministration (with the personal data of any such claimants making maladministration claims redacted).

I request the total number of maladministration claims made against Barnet council in relation the the 2016 voting shambles.

I request the total number of maladministration claims that succeeded against Barnet council and the total amount required to be paid out by Barnet council in relation to those successful claims.

We have processed this request under the Freedom of Information Act 2000.

### Response

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

We hold no correspondence between 'the council' and the Electoral Commission in connection with the issues that occurred with polling station registers in Barnet at the London Mayoral and Greater London Assembly (GLA) elections in May 2016. All correspondence with the Electoral Commission in regards to those elections were from either the Electoral Registration Officer for Barnet or from the Constituency Returning Officer for Barnet and Camden. As neither the Electoral Registration Officer or the Constituency Returning Officer are listed as a public authority for the purposes of the Freedom of Information (FOI) Act 2000 (as they are neither specified in Schedule 1 of the Act nor has a Ministerial Order been made under s5 designating them as a public authority), any correspondence between them and the Electoral Commission was exempt from the provisions of the FOI act.

With regards to the other information requests made, no maladministration claims were made against the council with regards the May 2016 elections and subsequently no payments were made in relation to maladministration claims.

Following the issues at the May 2016 London Mayoral and GLA elections, an independent review of Electoral Services within Barnet was commissioned and the
