I am writing to obtain information under the Freedom of Information act (2000) in relation to your council and local newspapers. I would like information on the following:

- Public money given to your council from any concerned party to use for all projects relating to local* newspapers since 2014.**
- A financial breakdown of any funds given to or received from local newspapers since 2014.**
- Funds received from City Hall to be spent on media and local newspapers since 2014.**
- Information on what percentage of your annual budget goes to local newspapers, and for what purpose.**

***Local refers to any newspaper in London or the Greater London area.**
