Thank you for your request received on 14 October 2019, for the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information in relation to the cladding being removed from the buildings Granville Point, Harpenmead Point and Templewood Point. For each building, please provide the following information.

1. In relation to the initial installation of the cladding:

- a. The cost of installing the cladding in the first place.
- b. How the work was paid for e.g. from the government's Decent Homes programme.
- c. A list of the bids received during the procurement process for the installation of the cladding. For each bid, please provide the total cost quoted and, if available, the cladding material proposed. For the successful bid, please provide a list of any amendments made after tender.

2. In relation to the removal of the cladding:

- a. The cost of removing the cladding.
- b. The EPC rating for the building with the cladding on.
- c. The EPC rating for the building once the cladding has been removed.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under your Section 16 obligations, as to how I can refine my request to be included in the scope of the Act.

In any case, if you can identify ways that my request could be refined please provide further advice and assistance to indicate this.

I look forward to your response within 20 working days, as stipulated by the Act.

We have processed this request under the Environmental Information Regulations 2004.

Response

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.
