Pls provide details for the EN5 postcode of all surface water flooding incidents logged by Barnet Borough Council Call Centre and/or communicated by the Environment Agency to Barnet Council, between 2009 to 2013. Thank you.

We have processed this request under the Freedom of Information Act 2000.

Response

I am writing to inform you that the information you requested is not held by the London Borough of Barnet.

This is due to Highways Regional Enterprise taking over in October 2014. Unfortunately, we do not any have Highways Records that are backdated to the period between 2009-2013.
