We have processed this request under the Freedom of Information Act 2000.

Response

The council holds the information requested and the answers to your questions are below

1. The Department who deals with the process of the Claim for Council Tax Discount or Exemption

The Council Tax Department.

2. Once an application have need received please tell me the whole process and how decision are made.

There are several different discounts and exemptions for Council Tax and as such the process varies dependant on the discount or exemption being applied for. In general the information and evidence is reviewed and if the criteria is met, the discount or exemption is awarded.

3. Contact number of the department who deals with the Claim for Council Tax Discount or Exemption.

There is no direct number to our back office team, any questions can be answered by our Call Centre on 020 8359 2000.

4. The person responsible who deals with the Claim for Council Tax Discount or Exemption. Please give me manager's name and direct contact details. I want a real person's name not a computer generated name.

Discounts and exemptions are dealt with by a variety of officers and managers within the Council Tax Service. If you have a query relating to a discount or exemption please direct your query to local.taxation@barnet.gov.uk.

6. Regulation and Criteria a claimants needs to meet to be exempt from Council Tax.

The decision to your appeal will provide details on how to escalate your appeal to the Valuation Tribunal Service should you remain dissatisfied with that decision. The Valuation Tribunal Service is a free, independent

service that reviews the decisions of Council Tax services and any decision they make is binding on the Council.
