Yes the council currently utilises the LASER Buying Group (Kent County Council) Framework.

The Councils Corporate supply Contract is utilised by most aspects of the organisation across its building portfolio / operational estate including:- offices, depots, libraries, parks, schools, landlord supplies etc.

## - the supply arrangements

Supplies are arranged through the Framework with Npower (electricity) & Total Gas & Power (Gas).

#### - who is the contract with

LASER Buying Group (Kent County Council).

#### - when is the contract due for renewal.

1 st October 2020 when the Council proposes to join the Pan LEP (London Energy Project) Framework administered by LASER for a period of three years with an option to extend for a further two years.
