Please can you help me with the following Freedom of Information Act request?

- In the financial year 2009/10, or if this information is not held in the most recent year prior to 2018/19 for which figures are available, how many School Crossing Patrol Officers (or persons with equivalent job titles) were employed by the authority?
- How many Full Time Equivalent hours did they work over the course of the year?
- How many School Crossing Patrol Officers (or persons with equivalent job titles) were employed by the authority in 2018/19?
- How many Full Time Equivalent hours did they work over the course of the year?

We have processed this request under the Freedom of Information Act 2000.

#### Response

The council holds the information requested and it is attached/ the answers to your questions are below

- In the financial year 2009/10, or if this information is not held in the most recent year prior to 2018/19 for which figures are available, how many School Crossing Patrol Officers (or persons with equivalent job titles) were employed by the authority?

2014 - 3

2015 - 4

2016 - 4

2017 - 4

- How many Full Time Equivalent hours did they work over the course of the vear?

The SCPO's in Barnet usually undertake the role as part of the overall position such as Caretaker or Teaching Assistant. They typically work between 8 -10 hours per week in their SCP role.

## - How many School Crossing Patrol Officers (or persons with equivalent job titles) were employed by the authority in 2018/19?

We do not hold the information you request regarding School Crossing Patrol Officers during the financial year of 2009/10. Since March 2011, Barnet Council ceased to employ School Crossing Patrols. At that point, there were four schools with a SCPO employed by the Authority. SCPOs are currently employed directly by schools and Barnet Council provide the training, uniform and monitoring.

# - How many Full Time Equivalent hours did they work over the course of the year?

We do not hold this information as schools can employ a School Crossing Patrol Officer (SCPO) without informing the Since 2011 School crossing patrol officers (SCPO's) have been paid for by the individual schools, with the exception of one school were the post is sponsored by a local business.
