Response

I can confirm that London Borough of Barnetholds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below / attached.

Specifically, I would like information on:

No specific budget was allocated and there were no specific costs that were incurred in 16/17, 17/18 18/19.

in 2018/19 £19k was spent on officer time; this was funded from government funding for Brexit preparations but I think to be out of scope as not budget, the grant was used for a Strategy Officer who supported coordination of information from across the council and partners to enable the council to understand and mitigate potential impacts.

There were other costs in staff time but that we don't hold information quantifying these as this was work undertaken by LB Barnet Officers in addition to their substantive duties.

We consider that the absolute exemption set out in Section 21 (Information accessible by other means) applies to the information requested because the information requested is already reasonably accessible elsewhere.
