# 2. Does the Council have any proposals for, or is it considering preparing any proposals for, the alleviation of congestion in Woodhouse Road and/or Friern Barnet Road ? If so, please provide particulars.

A proposal is in design for introduction of a right turn filter at the junction with Woodhouse Road. This is based on a feasibility study undertaken in 2016 (attached - see principally section 9 pp93 to 103 of pdf, drawing at p279) that proposed measures based on preliminary modelling. This modelling and the design is being refined and updated in the light of changes since the original feasibility study was undertaken.

The measures proposed consist of:

- Yellow box markings close to the Friern Barnet Road exit to manage the queues through
- the junction and minimise blocking
- A right turn indicative arrow stage on the A1003 Woodhouse Road approach
- Advance cycle stop lines
- Right turn markings added to the centre of the junction
