Thank you for your request received on 28 November 2019, for the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information.

- * How many stray dogs entered pounds between 1st January 2014 and 28th November 2019?**
- * How many of these were reclaimed by their owners?**
- * How many were adopted from the pound?**
- * How many went to an animal rescue centre?**
- * How many were euthanised?**
- * What happened to any remaining dogs that did not fall into the above categories?**
- * Do you keep any records as to the breed of the dogs?**
