Can I also have a copy of the entries in the book or electronic record above for the calendar years 2016, 2017, and 2018 and up until 26 October, 2019.

As no reply has been received to the request for clarification w e are refusing your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

There are thousands of records to be searched to extract the data at least half of which are not held electronically. It would take approximately 67 hours to extract the data (redaction time not being included in this calculation).

### **Advice and Assistance**

If there are specific records that you are seeking I would be glad to search for them and if not exempt under s.40 to provide them to you.
