I can confirm that London Borough of Barnet holds the information you requested. However, we believe that the exemptions detailed below apply to all the information you requested and so we are withholding that information. Please see the Refusal Notice below.

We are withholding the information under Section 31 (Law enforcement) subsection 1(c) Administration of Justice, therefore we have decided to withhold the information request as this could undermine enforcement. In applying this exemption, the Council have had to balance the public interest in withholding the information against the interest in favour of disclosure and where the exemption applies, information is held but not being made available.

Factors in favour of disclosure

- Transparency
- There is a legitimate public interest in understanding how parking is enforced

Factors in favour of withholding

- High risk and likelihood of contravention of waiting and parking restrictions (Part 6 of The Traffic Management Act 2004)
- Publicising this information could limit the effectiveness of parking Enforcement

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
