Thank you for your request received on 26 November 2019, for the following information:

- 1, Any recorded instructions or standing orders to Civil Enforcement Officers relevant to the claim that there was no waiting time in this Borough**
- 2, Whether Enforcement Officers are employees of the Borough or of any other sib-contracted entity, and if so, the name of the entity.**
- 3, Whether Enforcement Officers are paid solely on a salaried basis, or on any bonus or similar arrangement relating to notices issued or charges paid.**

We have processed this request under the Freedom of Information Act 2000.

Response

The council holds the information requested and it the answers to your questions are below

1, Any recorded instructions or standing orders to Civil Enforcement Officers relevant to the claim that there was no waiting time in this Borough.

- The Civil Enforcement Officer is making reference to observation times, the process where an officer will delay issuing a penalty charge after identifying a contravention. When a vehicle is parked in a residents' permit bay the officer is not required to give a specified observation period. Barnet's agreed observation periods are contained in our publicly available parking policy.

2, Whether Enforcement Officers are employees of the Borough or of any other sib-contracted entity, and if so, the name of the entity.

- Civil Enforcement Officers are employed by NSL Services Limited.

3, Whether Enforcement Officers are paid solely on a salaried basis, or on any bonus or similar arrangement relating to notices issued or charges paid.

- Civil Enforcement Officers are paid purely on a salary/wage basis. No payment is made on the basis of penalties issued of charges paid.
