- 2. The number of reports of, or complaints regarding, breach of the maximum 90-day letting limit relating to short-term lets such as Airbnb in each financial year from 2015/16 to 2018/19 (or the most recent figures available).
- 3. The number of reports of, or complaints regarding, unlawful subletting of council owned properties relating to short-term lets such as Airbnb in each financial year from 2015/16 to 2018/19 (or the most recent figures available).
- 4. The number of investigations into unlawful subletting of council owned properties relating to short-term lets such as Airbnb in each financial year from 2015/16 to 2018/19 (or the most recent figures available) by the council.
- 5. For point 4, please can you also detail the outcomes of any investigations that have been concluded, in each financial year from 2015/16 to 2018/19 (or the most recent figures available).
