We have processed this request under the Freedom of Information Act 2000.

### Response

The council holds the information requested and the answers to your questions are below:-

### 1. The number of social workers currently working for the authority

We currently employ 157 Social Workers directly via London Borough of Barnet within roles in our Social Work Career Grade structure.

### 2. The number of these social workers that are either contingent or temporary

In addition to the above we also contract 91 workers via employment agencies.

### 3. The total yearly spend on these contingent or temporary social workers

£4,323,801 per annum.

### 4. Do you have an apprenticeship scheme in place

Yes

## 5. If yes to No. 4, how many apprentices do you currently have?

Currently at 77 but this is due to change to 65 in January as completions are going through this month.

# 6. If yes to No. 4, which service areas/departments are these apprentices working in?

Community Schools, Finance, Street Scene, Adults, Audit, Performance and Improvement
