Thank you for your request received on 6 December 2019, for the following information:

# 2. Do HMO properties require mandatory acoustic insulation and the passing of a sound test?

In terms of sound testing (Building Regulations) there is no requirement to test sound resistance for HMOs. However, for HMOs that contain more than 7 bedrooms there would be control over the level of sound resistance in dividing walls, ceilings and in some cases party walls. But again, this would not be tested. That's as simple as I can put it without plans.
