Thank you for your request received on 9 December 2019, for the following information:

Dear Barnet Borough Council,

**I am interested to know whether:**

***(a) You hold personal email addresses as part of your Electoral Register, and if so,***

***(b) how many emails you hold in the Electoral Register;***

***(c) What the source or sources of these emails is;***

***(d) Whether you have included all or some portion of these emails as part of the datasets you gave to election candidates at the 2019 General Election;***

***(e) If so, how many emails were supplied;***

***(f) Whether you supplied email details in other prior elections.***

We have processed this request under the Freedom of Information Act 2000.

## **Response**

I am writing to let you know the Freedom of Information Act does not list any person appointed under the Representation of the People Act, 1983, which is the principle legislation governing elections and electoral registration. Therefore, the Electoral Registration Officer, Returning Officer or any other person appointed under the Act are not subject to the provisions of the Freedom of Information Act

However, in order to assist with your enquiry I can provide the following responses provided by our Electoral Registration team:

***(a) You hold personal email addresses as part of your Electoral Register, and if so,***

We do hold email addresses that have been supplied by elector on the software system that maintains the electoral register

**(b) how many emails you hold in the Electoral Register;**

We cannot supply a number but we hold an email for approx. half of our electors

**(c) What the source or sources of these emails is;**

These emails have all been supplied directly by the individual elector – no emails are taken from other sources

**(d) Whether you have included all or some portion of these emails as part of the datasets you gave to election candidates at the 2019 General Election;**

No emails have ever been supplied to election candidates at any election

**(e) If so, how many emails were supplied;**

Please see answer to (d)

**(f) Whether you supplied email details in other prior elections.**

Please see answer to (d)
