Thank you for your request received on 9 December 2019, for the following information:

How many highways in the London Borough of Barnet which have had carriageway resurfacing carried out in the last five years, have now or are scheduled to undergo large scale excavation road works as part of the Affinity Water Lead Replacement Programme?

Why did the council not use its powers under section 58/58a New road and Street Work Act 1991 to prevent the damage to these recently resurfaced roads? If the council did exercise these powers, how many roads and what was the criteria for exercising this authority?

What was the original cost of carrying out the resurfacing work on roads which have now been dug up or are scheduled to be dug up as part of the Affinity Water Lead Replacement Programme?

Which road had the shortest time between being fully resurfaced by the London Borough of Barnet and then the Affinity Water Lead Replacement Programme starting on that particular road? How many months was this interval period?

We have processed this request under the Freedom of Information Act 2000.

Response

W e are refusing your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx 50 hours to comply with your request. Our calculation is as follows:

LB Barnet have undertaken carriageway resurfacing on approximately 300 roads in 5 years.

To check how many have undergone, or are scheduled to undergo large scale excavation road works as part of the Affinity Water Lead Replacement Programme, LB Barnete Highways would be required to cross check each road resurfaced against the New Roads and Street Works permit database, for permits granted to Affinity Water.

These checks take approximately 10 minutes per resurfaced road equating to 50 hours of total work time. We have to look at 300 roads and we estimate it will take 10 minutes per file which totals 50 hours.

Advice and Assistance

Under section 12 of the Freedom of Information Act 2000 we are required to provide the requester with some advice and assistance as to how they could resubmit a refined request. You could consider reducing the number of years, or specific roads only, your request covers to one year to bring the request within 18 hours.
