- * Suggested examination and repair/adjustment/easing of window to first floor rear middle bedroom
- * Suggested to check first floor landing cupboard containing a washing machine, to ensure 30-minute fire resistant construction and be fitted with a smoke detector. Alternatively, to remove the washing machine from that location
- * Suggested decorative repairs to first floor landing
