For Q2 to Q5 – we are unable to provide the information on how many Care proceedings our Local authority has initiated in the financial year where the subject child was of Romanian nationality and /or Romanian ethnic background as the numbers are very low.

*Please note that we omit the data where the values are 5 or less as this could reveal the identities of the children/member of staff. We consider that this information is exempt under section 40 of FOIA. Please see the refusal notice below.

Refusal Notice

Section 40 FOIA sets out an exemption from the right to know if the information requested is personal information protected by the Data Protection Act 1998 (DPA).

The DPA which governs the processing of personal data and defines personal data "as any data which relate to a living individual who can be identified from those data, or from those data and other information which is in the possession of, or is likely to come into the possession of, the data controller."

Section 40 (2) FOIA exempts disclosure of information if such disclosure would contravene one of the data protection principles. This exemption is absolute and is not subject to the public interest test.

The first of the data protection principles requires that personal data is processed fairly and lawfully. It is our view that to disclose the withheld information would breach this principle, in particular, the requirement of fairness because the children have a reasonable expectation of privacy and do not expect that their personal information would be released in a response to a freedom of information request.

Qualitative Information:

10. What do you find to be main challenges in the assessment and direct work with Romanian speaking families?

Challenges can include language, cultural expectations in respect of education and parenting, mistrust of statutory organisations. These factors can also be present in other families of different nationalities.

11. What do you find to be the challenges in providing support to the Romanian speaking families?

Parents do not always accept support that is available and can be reluctant to work with agencies, this may be due to a lack of understanding of the concept of 'help and support'

12. Does your local authority's early help service offer parenting groups in Romanian?

We do not have a sufficient level of demand to deliver parenting programmes in Romanian at this time, we are able to work with families effectively using interpreters when necessary.

13. What do you believe would be beneficial to your service to make the work with Romanian speaking families more effective?

Community based support to assist and encourage access to ESOL courses and provision of information about services including UK expectations of parents to meet children's education, health and social and emotional development needs
