Thank you for your request received on 6 January 2020, for the following information:

- 1. Percentage of PCN's that the issuing officer has had appealed since his employment.
- 2. Percentage of appeals against that officers PCN's that are upheld.
- 3. Evidence of the traffic order stating that there are restrictions where my car was parked on Field Mead.
- 4. Evidence of the dates of said traffic order.
- 5. Evidence of the relevant signs on Field Mead informing road users of the parking

restrictions at that location.

- 6. Evidence that the relevant road signs were present on the day and time in question, as you provide no evidence of this in the pictures you rely on.
- 7. Any discipline matters around the conduct of the officer issuing the ticket.

We have processed this request under the Freedom of Information Act 2000.

Response

The council holds the information requested and the answers to your questions are below and attached.

- 1. Percentage of PCN's that the issuing officer has had appealed since his employment.
- 0.6% of Penalty Charge Notice's issued by the Civil Enforcement Officer in question resulted in appeals being made to London Tribunals.
- 2. Percentage of appeals against that officers PCN's that are upheld.
- 43% of the appealled Penalty Charge Noitices were upheld.
- 3. Evidence of the traffic order stating that there are restrictions where my car was parked on Field Mead.
