Thank you for your request received on 13 February 2020, for the following information:

I trust you are well, i wanted to inquire about a few points regarding HMOs. The questions below are speculative and do not relate to any ongoing cases. If you could let me know the details of all the below it would be greatly appreciated.

Firstly, I would like the exercise freedom of information to know about about HMO prosecution stats in Barnet and Haringey and London in general in 2018 and 2019 if possible.

Secondly, can you let me know what the average fines are for operating an unlicensed HMO. Is there any reasoning for fine amounts e.g. lower threshold for first time offenders or such?

Finally, can you let me know the actual process of appealing a fine for not having a HMO licence.

We have processed this request under the Freedom of Information Act 2000.

Response

The table below provides some information on successful prosecutions by the London Borough of Barnet in the years in question for a failure to obtain an HMO licence contrary to Section 72(1) of the Housing Act 2004.

We do not hold any information with the respect to the London Borough of Haringey which is a separate public authority.

^{*}In some cases, convictions for other offences were obtained at the same time for which additional fines were imposed by the court.

The fines shown do not include the council's costs awarded or victim surcharges levied.

We do not have any information with respect to the amount of the fines in these cases. This will have been a matter for the court which presumably will have reflected upon the seriousness of the offence, pleadings and any mitigating circumstances.
