We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below.

A list of unoccupied dwellings owned by non-individuals that had been empty for six months or longer as of 10/3/2020

**** addresses of any empty buildings (be it commercial or residential or industrial or industrial or storage facility etc) owned by yourselves which are available for disposal***

**** Addresses of empty commercial units (6 months or longer). Commercial units being Offices, Shops, Warehouses that are privately owned***

We consider that the absolute exemption set out in Section 21 (Information accessible by other means) applies to the information requested because the information requested is already reasonably accessible elsewhere.
