RE (Regional Enterprise) Limited

RE (Regional Enterprise) Limited, or Re, is a Joint Venture between London Borough of Barnet and Capita plc. Re will provide development and regulatory services (DRS) to residents in Barnet and the South East. The company was formed in October 2013 to enable the council to benefit financially from the profits anticipated from the commercial opportunity that the partners have identified, as it has a 49% stake in the business.

BXS Limited Partnership

BXS LP has been setup as a joint venture between the London Borough of Barnet and Argent related to manage the delivery of the Brent Cross South element of the Brent Cross Cricklewood Regeneration scheme. The joint venture ensures the protection of Barnet's interests in delivering a scheme that represents value for money for the Councils land contributions, and ensures the wider aspirations of the councils objectives are met in delivering the regeneration of the area.

Hillgreen Homes Ltd, which isn't operating at the moment but has been registered with Companies House as out Wholly Owned Housing Development company.

The Barnet Group

The Barnet Group is a Local Authority Trading Company that is wholly owned by the London Borough of Barnet. It was formed in 2012 as a parent to:

- Barnet Homes an Arms-Length Management Organisation (ALMO) established in 2004 to manage approximately 15,000 council-owned properties within Barnet. In 2012 the council's Homelessness service also transferred to Barnet Homes, which now discharges the statutory homeless duty.
- Your Choice (Barnet) an adult social care company formed in 2012 to receive the transfer of Adult Social Care services from the council.
- TBG Flex an employment company formed in 2015 to employ and supply new employees within The Barnet Group.
- TBG Open Door ('Opendoor Homes') a housing association that is a subsidiary of Barnet Homes. It was registered with the then Homes and Communities Agency as a private registered provider in April 2017, and is developing new properties within Barnet.
- Bumblebee Lettings an online private lettings service in Barnet and the surrounding areas, launched in May 2018.
