By location, I would like the name of the borough/district the properties are situated in. By cost, I mean the purchase price of the properties.

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

Temporary Housing would be held by Barnet Homes Housing services (including homelessness, allocations, housing repairs and so forth) are provided by Barnet Homes who are an Arm's Length Management Organisation (ALMO) who manage the council's housing stock and associated services on the council's behalf.
