Thank you for your request received on 8 April 2020, for the following information:

To this end I would be grateful if you could kindly confirm / provide the following information;

1). Is the provision and maintenance of your current street furniture (e.g. Bus Shelters) funded or partially subsidised by advertising?

2). Do other outdoor advertising contracts exist unrelated to Street Furniture provision (e.g. Free standing 6 sheet units / wall mounted displays on Local Authority owned buildings and land)?

3). If so, please confirm the contract start and end dates, together with the name(s) of the incumbent Media Owner / Maintenance provider.

4). Please also provide number and type of advertising panels involved (e.g. digital / back-lit) and the advertising revenue generated if possible.

I would be interested in any other relevant information held by your organization regarding this request.

I understand that I do not have to specify particular files or documents and that it is your department's responsibility to provide the information I require. If you need further clarification, please contact me by email.

I would like to receive the information in Word or Excel format.

If my request is denied in whole or in part, I ask that you justify all deletions by reference to specific exemptions of the Act. I reserve the right to appeal your decision to withhold any information or to charge excessive fees.

I would be grateful if you could confirm by email that you have received this request and look forward to your response within 20 working days as outlined in the Statute.

We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below.

1). Is the provision and maintenance of your current street furniture (e.g. Bus Shelters) funded or partially subsidised by advertising?

2). Do other outdoor advertising contracts exist unrelated to Street Furniture provision (e.g. Free standing 6 sheet units / wall mounted displays on Local Authority owned buildings and land)?

Bus Shelter and Free Standing 6 sheet units – Clear Channel – just awarded – 15 year contract.

Digital Advertising displays – individual License and Leases with J.C Decaux and Clear Channel.

Roundabouts Contract – tender analysis just completed and ready to award contract – see Refusal Notice below.

Gateway Signs Contract - tender analysis just completed and ready to award contract – see Refusal Notice below.

Lamp Post Banners – provided via existing Street Lighting PFI Contract

The PFI Service Provider is Barnet Lighting Services Limited (BLS). BLS subcontracts all the street lighting service to Bouygues Energies & Services (Bouygues E&S), formerly ETDE Infrastructure Limited (ETDE).

A mixture of Digital and back lit displays – 90 in total (6 Sheet) and D48 digital for larger displays – 6 in total. The income generated is considered commercially sensitive. See Refusal Notice below

Refusal Notice

We consider that the qualified exemption set out in Section 43 (Prejudicial to commercial interests) subsection 2 applies to the information requested. Therefore, we have decided to withhold the information.

Therefore, we have decided to withhold the information.

In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

Factors in favour of disclosure

When considering factors which would favour disclosing the information, the Council

had to assess whether disclosure of the information would

- assist the public to understand and challenge our decisions.
- allow for more informed debate on the issue;
- Promote accountability and transparency for our decisions and in our decision making process
- Assist the public to understand and challenge our decisions.

Factors against disclosure

Against these considerations the Council had to balance the likelihood of disclosure having an adverse affect on the commercial interest of the tenderers concerned and the Council itself and revenues accrued.

• The reason for this is by releasing the information it would be potentially damaging to the business of the supplier to share their pricing with third parties and would likely prejudice the commercial interest of the parties concerned. The Council considers that it would not be in the public interest to release this information as it is likely to be damaging to the business of the supplier. It might also have a negative impact on fair competition in future tender processes and that it is not common knowledge and would likely be used by competitors in a particular market to gain a competitive advantage. The Council also considers that disclosure of such information would be damaging to the Council's commercial interest as it would be likely to:

(a) discourage companies/individuals from providing the Council with commercially sensitive information in the future or undertaking contracts with the Council;

(b) adversely affect the Council's bargaining position during future contractual negotiations.

The public interest in withholding the requested information outweighs the public interest in disclosure of the requested information, and this information cannot be supplied to you
