As and from 01/11/2020\*, the London Borough of Barnet (the administering authority) pensions administration contract will be provided under a shared services agreement with West Yorkshire Pension Fund.

The decision to change administrators was approved by the Policy & Resources Committee on 19 February 2020 and ratified by full Council on 3 March 2020. There are no minutes to these meetings at present.
