To whom it may concern,

I am writing to you regarding speed limits changes, which might be planned in 2020 in your borough. Could you please provide us with information?

- \* If permanent speed limit changes are planned in 2020 in your borough. In this case please provide us the source, preferably in GIS format, where speed limit changes will be and time when changes will be valid from.
- \* Otherwise, please send us a confirmation, that speed limit changes are not planned in 2020 in your borough.

## Response

The council holds the information requested and the answers to your questions are below.

- \* If permanent speed limit changes are planned in 2020 in your borough. In this case please provide us the source, preferably in GIS format, where speed limit changes will be and time when changes will be valid from.
- \* Otherwise, please send us a confirmation, that speed limit changes are not planned in 2020 in your borough.

Please see attached a list of permanent speed limit changes being progressed in 2020 within the London Borough of Barnet on borough controlled roads. We are sorry this is not available in a GIS format. This list may not be exhaustive as additional proposals may develop in year and it is also possible that some proposals may ultimately not proceed in full. An operational date for all locations is uncertain at the moment, but we have provided an indication of the current position as a note where we think this might help. The information does not include potential speed limit changes on roads not controlled by Barnet (e.g. M1, A1, A41, A406).
