Thank you for your request received on 1 June 2020, for the following information:

If we use C (3) family dwellings as this planning use below, what evidence do we need to provide for you to certify its use?

We wish to avoid any future planning disputes.

This is a generic question as we plan to set up a lot of these units across your Borough.

If you can send us over some planning decisions with such lawful use approvals it would be most beneficial to us in us providing you with the right information.

Our aim is to work with you on all such supported living set ups.

C3(b) covers up to six people living together as a single household and receiving care e.g. supported housing schemes such as those for people with learning disabilities or mental health problems

We have processed this request under the Environmental Information Regulations 2004.
