Thank you for your request received on 4 June 2020, for the following information:

**Under the Freedom of Information Act 2000, please provide me with:**

- 1) A list of full postal addresses of all buildings (and any land within its curtilage) which were classified with sole use Class B1(c) (light industrial) within the borough on 19 March 2014 or earlier.**
- 2) A list of full postal addresses of all buildings (and any land within its curtilage) with B1(a) use class as at 29 May 2013.**
- 3) A list of full postal addresses of all buildings (and any land within its curtilage) which have current use classification as D2 betting office / pay day loan / amusement centre or casino.**
- 4) A list of full postal addresses of all buildings (and any land within its curtilage) with current A5 use class.**

**Please exclude any buildings which are listed buildings or is in what is termed a 'safety hazard area' or military explosives area for all of the above.**

**Please exclude any buildings which are part of a World Heritage Site for all of the above.**

**Please exclude any buildings in a conservation area for all of the above.**

**Please exclude any buildings which have an Article 4 direction for all of the above.**

**I understand that under the Act I am entitled to a response within 20 working days of your receipt of this request. Some parts of the request may be easier to answer than others. Should this be the case, I request that you release information as soon as possible. If my request is denied in whole or in part, I ask that you justify all deletions by reference to specific exemptions of the act. I will also expect you to release all non-exempt material.**

**I reserve the right to appeal your decision to withhold any information or to charge excessive fees. I would prefer to receive the information electronically. If you require any clarification, I expect you to contact me under your section 16 duty to provide advice and assistance if you find any aspect of this FOI request problematic.**

We have processed this request under the Environmental Information Regulations 2004.

## Response

I can confirm that London Borough of Barnet holds the information you requested. However, we consider that the following exceptions apply to some of the information requested.
