Thank you for your request received on 8 June 2020, for the following information:

All the following questions are in relation to front entrance fire doors in your housing stock:

Do you have a current fire door replacement programme in place? What is the timeline for this?

Is there a tender process for the replacement of any fire doors? If so, how does this work?

Is there a main contractor appointed for installation of fire doors? Who is this? Is there a fire door manufacturer specified for the supply of fire doors? Who is this?

What are the contact details for the person in charge of procurement of fire doors?

We have processed this request under the Freedom of Information Act 2000.

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.
