Please see the attached spreadsheet titled Etchingham Park Road N3, (Northbound) which includes data from the 4 vehicle activated signs within Etchingham Park Road, N3 (northbound), Etchingham Park Road, N3 (southbound) Park View Road, N3(eastbound) and Park View Road, N3 (westbound)

As you will see from the date ranges we don't necessarily have full months of data in any given time period, however the information provided should give an overview of traffic speeds/volumes in these roads.

We have (until recently) been operating a kind of rolling programme to collect data from our VAS sites (to allow us to obtain information from the various sites we have across the borough). This work has been paused since March 2020 and the most recent download we have on file is from January this year as we have not been able to carry out site visits in recent weeks due to the COVID-19 pandemic.
