Thank you for your request received on 23 June 2020, for the following information:

**I am requesting the following information under the Freedom of Information Act.**

**This is a lengthy request; however, all but question 9 are for statistical data.**

**Please note this request has no questions 1-4 or 10-14.**

#### **Council tax**

**The council may have introduced waivers or deferrals of council tax bills for households during the coronavirus pandemic. My preference is for the council to exclude from questions 5 -8 those households whose council tax for the relevant months has been waived (i.e. cancelled) during the pandemic, but to include those households whose council tax for the relevant months has been deferred (i.e. delayed).**

**However, while this is my preference, it is not a requirement, and if it is not possible please just provide the data for the whole council tax cohort (or the CTS cohort for questions 7 and 8).**

**6. How many households still owe council tax for April 2020 (i.e. they have not fully paid their council tax bill for April)?**

**7. How many working age households are in receipt of Council Tax Support?**
