Guidance issued by the EU Commission and UK bodies, in relation to the use of pesticides, is regularly monitored and policy will be updated in-line with their recommendations.

4. Are the services which delivers weed management for the areas described in question 1 delivered "in-house" or are they outsourced? (Please list and record for each service).

Parks, open spaces and shrub beds are delivered in-house and treatment of the public highway is outsourced.

4a. If the services in question 3 are outsourced, which contractors provide each of the services and what are the durations of the contracts in each case?

Treatment of the public highway is delivered by Weedfree Ltd and the duration of the contract is 1 year, 01/04/2020 – 31/03/2021.

5. How many complaints did the Council receive in each of financial years 2017-18, 2018-19 and 2019-20 in relation to weed management and use of weedkillers?

Response – The number of complaints are as follows:
