Please could I request the following information under the Freedom of Information Act:

- 1. Does your local authority currently provide a school uniform grant?
- 2. If no, did your local authority ever provide one and if so, when was it withdrawn?
- 3. If yes- how many grants were issued and how much was spent on school uniform

grants in (a) 2015/16 and (b) 2019/20?

4. Does your local authority plan to provide a school uniform grant for the year 2020/21?

We have processed this request under the Freedom of Information Act 2000.

Response

The council holds the information requested and the answers to your questions are below

Please could I request the following information under the Freedom of Information Act:

1. Does your local authority currently provide a school uniform grant?

Yes. there is a Mayor's Benevolent Fund under which school uniform grants can be made

There is also a crisis fund, where school uniform need is identified and the request doesn't fall within the eligibility criteria for the Mayor's Benevolent Fund, see Refusal Notice below.

2. If no, did your local authority ever provide one and if so, when was it withdrawn?

3. If yes- how many grants were issued and how much was spent on school uniform grants in (a) 2015/16

In 2015/16, there were 23 school uniform grants totalling £1,500.

and (b) 2019/20?

37 school uniform grants totalling £3,625.

4. Does your local authority plan to provide a school uniform grant for the year 2020/21?

Refusal Notice

We are refusing part of your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx 74 hours to comply with your request. Our calculation is as follows:

We would have to look at 2337 files and we estimate it will take 2 minutes per file which totals 74.50 hours .

Advice and Assistance

The crisis fund very rarely helps with school uniforms where a need is identified and the request doesn't fall within the eligibility criteria for the Mayor's Benevolent Fund, however we don't keep separate records for this, and we would have to look through all the applications received in order to find the cases, if any, It is unlikely that there is significant information held on school uniform grants under crisis loans and we unable to suggest a way of narrowing the request.
