Thank you for your request received on 8 July 2020, for the following information:

- 4. What was the proportion of black children in ESN schools compared to black children in mainstream schools?
- 5. Do you have on record the names of the teachers and head teachers that taught at ESN schools in the '60s and '70s?
- 6. Do you have names of students or notable alumni that attending these ESN schools in the '60s and '70s?
