Thank you for your request received on 25 June 2020, for the following information:

### Dear Sir/Madam

Our Artisan club at Dyrham Park require help or pointing in the right direction.

I am an Artisan member at Dyrham Park Golf and Country Club, Galley Lane, Barnet EN5 4RA.

The Artisan Section of the Golf Club has been running for the last 54 years. We independently built our small clubhouse on land donated to us in the mid seventies.

On the 4th June 2020 we were given notice by Dyrham Park Golf Club (DPGC).Informing our 24 members that they are shutting down our Golf Club section as we were no longer needed at DPGC. The notice to leave will run out in September 2020.

The question our members would like to know is:-

- 1. As Dyrham Park lease the land from Hertsmere Council. We believe that in the lease there is a clause stating that Artisan Golf is part of lease agreement. We believe the information on the Lease should fall under the freedom of information act
- 2. The small plot of land given to us was in agreement with The GLC now Barnet Council's Lease and DPGC.

I hope you can answer these questions or point us in the right direction.An early reply would be excellent as there are 24 Artisan members the majority living in Barnet and Borehamwood waiting for a reply.

We have processed this request under the Freedom of Information Act 2000.

## Response

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

The Records Management lead has checked Deeds records, Property Services, records held by the Governance team in Assurance Group and Harrow and Barnet Public Law can locate no records of the lease agreement which you are seeking.
