Thank you for your request received on 28 July 2020, for the following information:

The Local Authority does not pay LSA's. Schools are responsible for paying LSA's.

ASD Year 1 – 85 EHC Plans, 19 of which have special school named in Section I of their EHCP

ASD Year 2 – 68 EHC Plans, 24 of which have special school named in Section I of their EHCP

Team is now at 4.0 capacity.

10 times for students. Please note that direct casework is only carried out with pupils when a referral is made to the Autism Advisory Team. The level of support receives as direct casework depends on the individual needs of the pupils, the criteria for the level of support provided is described in the "Working With the Autism Team" document.

6. If the local authority has to buy in ASD specialist teacher hours for students with ASD, please confirm the normal rate of pay for 1:1 tuition is still £65 per hour.

This is £70 an hour for additional support, however we do not do 1:1 tuition. We only work in an advisory capacity.

7. Please confirm the cost to buy in the services of an independent OT or SLT if required is £75-£100 per session.
