Thank you for your request received on 8 July 2020, for the following information:

**Dear Sir/Madam,**

**I am writing to you to request information under the Freedom of Information Act 2000 about allegations against adults who work and volunteer with children.**

**Please provide the following information for the years 2016, 2017, 2018 and 2019, broken down by year:**

**A) Number of referrals made to your Designated Officer/LADO regarding physical chastisement in a sports setting (for the avoidance of doubt this could just be listed as "physical" but referral must also mention "sport" in some way)**

**B) Number of referrals made to your Designated Officer/LADO regarding emotional abuse/neglect in a sports setting (for the avoidance of doubt this could just be listed as "emotional" or "neglect" but referral must also mention "sport" in some way)**

**C) Of the cases covered in A and B), where this information is recorded, please provide the following detail:**

- \* age and gender of alleged victims involved (grouped by age: 0-5, 6-10, 11-15, 16-20, 21+)**
- \* gender of alleged victims involved (female/male/other, grouped together)**
- \* sport and context in which the alleged physical/emotional abuse took place (eg "gymnastics, group training, leisure centre" or "tennis, one-on-one coaching, private home")**
- \* gender of adult involved**
- \* job title of person subject to the allegation (eg coach)**
- \* who made the allegation (eg child, parent, other professional etc)**
- \* any anonymised detail you have of the nature of the alleged physical chastisement/emotional abuse**

**D) Of those cases in A and B), please provide figures for where other agencies became involved (eg police, sports federations), where applicable.**

**Given the filing requirements of the LADO, I'm hoping this information has already been collated and is therefore readily available. Please do not hesitate to contact me if you require any more information.**

We have processed this request under the Freedom of Information Act 2000.

## **Response**

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is attached.

***A) Number of referrals made to your Designated Officer/LADO regarding physical chastisement in a sports setting (for the avoidance of doubt this could just be listed as "physical" but referral must also mention "sport" in some way)***

***B) Number of referrals made to your Designated Officer/LADO regarding emotional abuse/neglect in a sports setting (for the avoidance of doubt this could just be listed as "emotional" or "neglect" but referral must also mention "sport" in some way)***

***C) Of the cases covered in A and B), where this information is recorded, please provide the following detail:***

***\* age and gender of alleged victims involved (grouped by age: 0-5, 6-10, 11-15, 16-20, 21+)***

Please note that we consider that the absolute exemption set out in Section 40 (Personal information) subsection 2 applies to some of the information requested. Therefore, we have decided to withhold the information. Please see Refusal Notice below.

## **Refusal Notice Section 40(2)**

[Part 1 of Schedule 19](#) of the Data Protection Act 2018 amends the personal data exemption under section 40 of the Freedom of Information Act 2000 (FOI). These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They will not fundamentally impact when personal data can, and cannot, be disclosed in response to an FOI request.

Personal Information is governed by the Data Protection Act legislation and is defined as any information relating to an identified or identifiable natural person

('data subject')". It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness.
