Thank you for your request received on 21 August 2020, for the following information:

I would be grateful if you could, as a request under the Freedom of Information Act provide me with the data in the attached spreadsheet for your local authority. I appreciate that there will inevitably be some discrepancy between the way different authorities hold the data and that, in some cases, it may not be broken down into these categories (where integrated contracts have been purchased for example). However, if you could provide as much data as possible, I will manipulate it appropriately.

We have processed this request under the Freedom of Information Act 2000.

## Response

I can confirm that London Borough of Barnet holds the information you requested. However, we believe that the exemptions detailed below apply to all the information you requested and so we are withholding that information. Please see the Refusal Notice below.

We consider that the absolute exemption set out in Section 21 (Information accessible by other means) applies to the information requested because the information requested is already reasonably accessible elsewhere.

Barnet has outsourced its Facilities Management to Capita. Details of the contract can be found at:
