- 3) How many fixed penalty notices have been issued for contravening traffic offences in the council area from March 23 to August 10?
- 4) How many fixed penalty notices were issued for contravening traffic offences in the council area for the time period March 23 to August 10 2019?
- 5) How much is the fine on receipt of a fixed penalty notice in the council area?
