Thank you for your request received on 9 October 2020, for the following information:

In the past 5 years, how many children (under age 18 years, who are UK citizens or have leave to remain in UK) were placed in county care due to one or more parents being detained by the Home Office relating to their immigration status? If relevant, how many of these children were reunited with parents after the parental detention?

We have processed this request under the Freedom of Information Act 2000.

Response

W e are refusing your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx [140 hours] to comply with your request. Our calculation is as follows:

We have calculated that it will take considerably over 18 hours to comply with your request. Our calculation is as follows: We have accommodated approximately 850 children over the past 5 years and it would take at least 10 mins to look at each case file to determine if the child/ren were placed in care due to one or more parents being detained by the Home Office relating to their immigration status, a total time of 140 hours

Unfortunately, we cannot see a way of reducing the request scope to bring it in within 18 hours appropriate limit.
