A percentage of the cycle parking funding has been provided to Barnet Homes to install secure bike hangars on Council run housing estates. A total of £125,164 has been used to fund approximately 30 Bike hangars at various Barnet Homes locations between 2014 and 2019. The breakdown is as follows:

2014-15 £99,350

2017-18 £5,250

2018-19 £20,564
