The hourly rate varies from £50 to £100 per hour depending on the private clinician commissioned. Travel costs may be additional or may be included, the funding agreement for these also vary depending on the time and distanced to be travelled.

The SLA covers children with EHCPs who attend schools within a 10 mile radius of Barnet, however as therapy provision may be delivered as part of the school offer and included in the funding charged to the LA for that placement there may not be a requirement on the SLA to deliver the provision.
