We have processed this request under the Environmental Information Regulations 2004.

Response

In order for me to make a proper representation to the CPZ team, could you please advise me as to how many house conversions have taken place in Selborne Gardens in the past 12 months.

The Valuation Office Agency also known as the VOA give all homes a council tax band. When houses are converted or extended the size and value of the property will often increase, and this could put the property into a different tax band. If the valuation list is changed, the VOA will inform the owner of this and the local authority will send the tax bill with the corrected price.

Council Tax has confirmed that there were no Council Tax band increases due to house conversions that have taken place in Selborne Gardens, NW4 4SJ in the past 12 months.
