Thank you for your request received on 11 January 2021, for the following information: **1. How many potholes were fixed in your area in 2020?**

2. How many complaints did you receive relating to potholes in your area in 2020?

3. How many claims for compensation did you receive relating to potholes in your area in 2020?

4. How much compensation was given to those whose vehicles were damaged by potholes in your area in 2020?

Additionally, if it's at all possible, I'd also be interested in the below data: 5. Were there any particular areas / roads that received the most pothole repairs? 6. Were there any particular areas / roads that receive the most pothole complaints?

We have processed this request under the Freedom of Information Act 2000.

Response

The council holds the information requested and answers to your questions are below. We are refusing some of your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester. Please see refusal notices below.

1. How many potholes were fixed in your area in 2020?

4,362 potholes were fixed in 2020

2. How many complaints did you receive relating to potholes in your area in 2020?

0 complaints received

3. How many claims for compensation did you receive relating to potholes in your area in 2020?

62 carriageway pothole claims received for incidents between 1 Jan 2020 and 31 December 2020.

4. How much compensation was given to those whose vehicles were damaged by potholes in your area in 2020?

£7,544.37

5. Were there any particular areas / roads that received the most pothole repairs?

Refusal Notice

Pothole figures are not held by road/area and therefore it is not possible to supply this information. To do so would require a search through files on the 4,362 potholes fixed in 2020 (as above) and would therefore exceed the appropriate limit set out in Section 12 of £450 which is equivalent to 18 hours at £25 per hour.

4362 files x 5 minutes = 363 hours.

6. Were there any particular areas / roads that receive the most pothole complaints?

As above for Q2 and Q5, 0 complaints received during 2020 for potholes
