Can a member of the public whistleblow on the police?

Yes, this request would be for the Independent Police Complaints Commission (IPCC).

Refusal Notice

We are refusing some of your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling

requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester. Please see refusal notices below.

We have calculated that it will take approx 450 hours to comply with your request as this information is not held or reported seperately from staff files. Dismissals of this kind are not recorded as 'whistleblowing' but as the action that was reported, this inconjunction with the time taken means our calculation is as follows:

1800 staff files x 15 minutes per file = 450 hours

Under further advice and assistance, we are unable to suggest how you might further narrow down your request to bring it under 18 hours.
