Thank you for your request received on 23 February 2021, for the following information:

I would be grateful if you could kindly confirm the following information under FOI:

- 1. Number of buildings in Barnet Local Borough that are residential and over 18m 2. Number of buildings in Barnet Local Borough that are non residential and over 18m 3. The number of buildings in Barnet Local Borough that have been identified as having ACM or other combustible external cladding solution over 18m (as defined by the MHLCG) 4. The number of buildings in Barnet Local Borough that have had ACM cladding removed since 2017 that are over 18m.
- 5. A list of the buildings and their addresses that are over 18m in Barnet Local Borough which have had combustible cladding removed 6. A list of the buildings and their addresses that are over 18m in Barnet Local Borough which have not had combustible cladding removed

We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below.

I would be grateful if you could kindly confirm the following information under FOI:

1. Number of buildings in Barnet Local Borough that are residential and over 18m

This information was not in scope of the most recent review and London Borough of Barnet does not have a complete dataset of this information. 3 buildings are known.

3. The number of buildings in Barnet Local Borough that have been identified as having ACM or other combustible external cladding solution over 18m (as defined by the MHLCG)

4. The number of buildings in Barnet Local Borough that have had ACM cladding removed since 2017 that are over 18m.

We consider that the qualified exemption set out in Section 38 (Health and safety) applies. Therefore, we have decided to withhold the information. In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

The public interest test is below:

Factors in favour of disclosure:

Furthering the understanding and participation in the public debate of issues of the day.

Promoting accountability and transparency by public authorities for decisions taken by them.

Promoting accountability and transparency in the spending of public money.

Allowing individuals, companies and other bodies to understand decisions made by public authorities affecting their lives.

Bringing to light information affecting public health and safety.

Factors in favour of withholding:

It is vital that residents are kept fully informed about the safety of their own buildings and we expect you to ensure that this is the case, however we believe there are public safety risks associated with releasing information, such as comprehensive lists, that allows buildings with cladding which is likely to present a hazard to be easily identified. In the absence of evidence other than that provided by MHCLG and advice provided from Cabinet Office we cannot be sure that arson would not be a risk.

We have therefore taken the approach that in requests made under the Freedom of Information Act, it is appropriate to withhold information that could lead to the identification of affected buildings.

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
