- (a) the total amount awarded (in £)
- (b) total number of applications
- (c) total number of applications granted

For each of the grants I would like the data for the last 3 years (if possible) or at the very least for the last 12 months. I'm aware some grants are newer than others. Worth noting, if providing data for the last 3 years would put this over the time/financial thresholds permitted by the FOIA, please just provide the data for the last 12 months.

If the FOI request is beyond the time/financial scope permitted by the FOIA, please narrow the scope by reducing the total number of grant programmes. They are listed in order of priority with the top 4 being the most important.

## \* SEN (Special Education Needs and disabilities)

SEN is not a grant programme. The way the London Borough of Barnet fund SEND is far more nuanced than giving specific grants. We have a high needs block within the Dedicated Schools Grant which we allocate to schools to spend on SEND. We also spend money on residential placements and direct payments to children with disabilities, however, following your clarification, we are not able to readily identify specific spend on SEN in the way that you have requested.

## \* Test & Trace Support Payment

Test and trace payment has been running for less than 12 months, so this is the complete data as of this morning.
