#### 4. What is the longest continuous period of time you have used a Locum for?

Three years

5. How many OT assessments do you expect a locum to carry our per week?

Dependent on case complexity - so not possible to determine accurately. Primary focus can be on one case taking a week; others may take a day. An estimation is four cases per week for each full-time (or equivalent) post.

## 6. What is the average price per hour you pay for an experienced Locum?

£32.99

## 7. How much have you spent on Locum OT's during the last financial year?

£498,187.

# 8. Would you expect a Locum to carry out any other duties e.g. supervision, attend team meetings or join in training?

Yes - locums would be expected to carry out the same responsibilities as a permanent employee in the same role.
